All participants must be able to use the breaks. 3. Participants requested to adhere to the break signs on the track. 4. First Aid kit will be present for the duration of the sessions. 5. Check use before decent. 	
Weather: sessions may become dangerous due to adverse weather conditions	All involved	M	Sessions may have to be cancelled during periods of heavy rain and storms.	




Hazards arising from the actions of group members i.e. Unauthorised entry onto the tracks during session. Falling down the banking Participant hitting another person on the way down. Participant stopping hard	All involved	L	<ol style="list-style-type: none"> 1. Group leader to ensure that all group members stay off the tracks during sessions. 2. Return path to be specified in session notes! 3. Visual check for bystanders in danger area before letting the participant go. 4. Braking instructions included in session notes, group leader to ensure all participants understand how to brake before they are let go. 5. Helmets must be worn by participants. 6. Check helmet before each run. 	
Hazards arising from the actions of group members i.e. Overcrowding Disorderly behaviour.	All involved	L	<ol style="list-style-type: none"> 1. Group leader must be present during sessions. 2. Management have final say on group size and may restrict size of group or amount of people in the waiting area at their discretion. 3. Group leader must ensure the good behaviour of the group throughout the session. 	

The following precautions apply when Covid alert is changed from Green

Hygiene Risk of Spread	All	L	<ol style="list-style-type: none"> 1. Hand sanitizer provided to be used by participant before and after each use of equipment. 2. Handbrake and seat to be wiped after session. 	
Social Distancing	All	L	Leaders to manage and enforce social distancing of the group.	
Track and Trace	All	L	The Group to provide Hesley Wood with a list of participants in each activity group, to be retained for 21 days. Group Leader to notify Hesley Wood if any participant becomes a confirmed Covid-19 case after event.
